Notification for Quarterly filing of information for those organisation who do not have Website

It may kindly be noted that Ministry of Home Affairs, FCRA Wing, Government of India has issued a circular dated 3rd March, 2016. Through this circular it has been notified that as per Foreign Contribution Regulation Amendment Rules, 2015 a person receiving foreign contribution in a quarter of a financial year, shall place details of foreign contribution received, on its official website or on the website specified by the Central Government, within fifteen days following the last day of the quarter in which it has been received, clearly indicating the details of donors, amount received and date of receipt. The organisations which do not have Website can upload the information at <https://fcraonline.nic.in>

Intimation of Quarterly Receipt of Foreign Contribution

Foreign Contribution Regulation Amendment Rules, 2015 provides for a person receiving foreign contribution in a quarter of a financial year, shall place details of foreign contribution received, on its official website or on the website specified by the Central Government, within fifteen days following the last day of the quarter in which it has been received, clearly indicating the details of donors, amount received and date of receipt.
